

Bidders should enroll / register in the e-procurement module of Central Public Procurement Portal through the website: www.eprocure.gov.in. The bidders should also possess a valid DSC for online submission of tenders / bids.

1. Tender Document can be downloaded from ICAR-CIFE website www.cife.edu.in or from Central Public Procurement Portal www.eprocure.gov.in. The Bidders should enroll / register in the e-procurement module of Central Public Procurement Portal through the website : www.eprocure.gov.in. Bidders should also possess a valid DSC for online submission of bids.
2. **Bids received on e-tendering portal only will be considered.** Bids in any other form sent through sealed cover/email/post/fax etc. will be rejected.
3. The Director ICAR-CIFE, Mumbai reserves the rights to accept / reject any /all tenders in part /full without assigning any reason thereof.
4. ICAR-CIFE will not be responsible for any delay in enrollment/registration as bidder or submitting/uploading the offer on e-tender portal. Hence, the bidders are advised to register in e-tendering website www.eprocure.gov.in and enroll their **Digital Signature Certificate** and upload their quotation well in advance.
5. **Any changes, corrigendum, proceedings of pre-bid meeting, etc. in respect of this tender shall be issued / notified only through on Central Public Procurement Portal www.eprocure.gov.in.** Bidders are therefore requested to regularly visit www.cife.edu.in website / Central Public Procurement Portal www.eprocure.gov.in. for updates.
6. **Earnest Money Deposit (EMD) :** An amount of **Rs. 43,700/- (Rupees: Forty Three Thousand Seven Hundred Only)** in the form of Demand Draft / FDR drawn in favor of **"ICAR Unit CIFE"** payable at **Mumbai** shall be paid. Failure to deposit EMD will lead to rejection of tender.
7. **EMD is not mandatory if the bidder has exemption certificate of like MSME, NSIC etc.**

SECTION – I

GENERAL INSTRUCTIONS TO THE TENDERERS

- (1) The present Work / Service / Job is to be executed for ICAR - Central Institute of Fisheries Education (CIFE), Panch Marg, Off. Yari Road, Versova, Andheri (W), Mumbai-400 061.
- (2) **SITE VISIT:** The bidder / tenderer is advised in his/her own interest to visit / examine the site of work before submission of his tender. He/she may obtain all relevant information that may be necessary for preparation of the bid.
- (3) The tenderer/bidder requiring any further information or clarification on the Tender document may contact the Chairman of the Pandal Committee of ICAR-Central Institute of Fisheries Education (CIFE) up to the closing date of the Tender during office hours only.
- (4) The tenderer must fill and submit the E-Tender document without making any additions or alteration in the tender document. Incomplete tenders and those submitted not as per the instructions are liable to be rejected. Conditional tenders shall not be accepted.
- (5) **Tender shall be submitted in ONLINE MODE ONLY.**
- (6) The **scanned copies of the following documents/ certificates** should be uploaded. For further details, please see the information provided in the Check List or qualification in Technical bids on Page No. 16:
 - (a) PAN, Establishment Registration, and GST Registration Documents
 - (b) Earnest Money Deposit (EMD) details (Demand Draft)
 - (c) Appropriate EMD exemption certificate, if claiming EMD exemption
 - (d) Copies of ITR of the last 3 years
 - (e) Balance sheet of the last 3 years certified CA
 - (f) Experience certificate of having done similar works (erection of Pandal / Shamiana / Stage etc.)
 - (g) Signed copies of Annexures I, II, & III
 - (h) Tender document signed by the Bidder / Agency
- (7) **Signing of document:** All pages of tender document including various annexure shall be signed and stamped at the lower right hand corner and wherever required by the tenderer and then uploaded on the portal.
- (8) **Earnest Money Deposit (EMD):** The tenderer shall pay an Earnest Money Deposit (EMD) of Rs. 43,700.00 (Rupees: Forty Three Thousand Seven Hundred only) along with the

tender in the form of Crossed Demand Draft payable to "ICAR Unit - CIFE" Mumbai. **The tenders received without the EMD in the prescribed form shall be rejected out rightly.**

- (9) The Earnest money of the tenderer shall be forfeited to CIFE without prejudice to any other rights or remedies.
- a) If the tenderer withdraws his tender during the period of tender validity specified in the tender document.
 - b) If, after acceptance of his tender, the tenderer fails to take up the job.
 - c) If, the tenderer fails to sign the contract in accordance with the terms and conditions of the contract.
 - d) If, after acceptance of his tender, the tenderer fails to furnish the Security Deposit.
 - e) If, after acceptance of his tender, the tenderer fails to commence the work within the scheduled time period after receipt of work order to that effect.
- (10) **Security Deposit:** The successful bidder will have to submit **5 % of the quoted amount** for the work (i.e. **Erection of Pandal for conducting the XIX Convocation**) excluding of Taxes etc. as Security Deposit in form of Bank Guarantee or Demand Draft before commencement of the work. The Security Deposit shall be released/refunded only after successful completion of Guarantee/Warranty period.

(11) PERIOD FOR WHICH OFFER WILL REMAIN OPEN:

Firms tendering should note that it is desired that their offers should remain open for acceptance for **90 days** from the date of opening of tender, if the firms are unable to keep their offers open for the specified period their tenders are likely to be rejected.

- (12) **Care in submission of tender:** Before submitting the tender, the tenderer shall be deemed to have satisfied himself by actual inspection of the site and locality regarding the site conditions, stacking space for materials, Approach roads, available working area, working conditions of the Institute, etc. that are likely to be encountered during the execution of works, and he shall be deemed to have taken all these factors into account while quoting his rates. The rate quoted by him shall be deemed to be all inclusive for completion of work to the satisfaction of Pandal Committee of CIFE, Mumbai.
- (13) The tender document shall not contain any interlineation, erasures or overwriting except as necessary to correct the errors made by the tenderer in which case such correction shall be initialed by the tenderer along with his company's stamp.
- (14) **Omission and Discrepancies:** Should a tenderer find discrepancies in, or omissions from the tender documents or any drawings or should be in doubt as to their meaning, he should at once notify the authority inviting the tenders, who may send written instructions to all the tenderers. It shall be understood that every endeavor has been made to avoid any error which can materially affect the basis of the tender and the successful tenderer shall take upon himself and provide for the risk of any error which may subsequently be discovered and shall make no subsequent claim on account.

- (15) **OPENING OF THE TENDER:** At the advertised date and time, the tenders received shall be opened. **Tender received after the due date and time is liable to be rejected.**
- (16) **THE QUOTED RATES** should be inclusive of cost of materials required for erection of Pandal, materials to be supplied on rental basis, labour charges, loading & unloading charges, transportation charges, contractor's profit, and cleaning of the ground after the programme is over. Taxes, as applicable as per Govt. norms, should be clearly mentioned in the bid; failing which, it will be presumed that the quoted rates are inclusive of all taxes. The rates quoted once shall not be increased under any circumstances. Any claim on account of tax or anything whatsoever it may be entertained after opening of tenders and placing the work order.
- (17) **Canvassing:** Any effort by the tenderer to influence the representatives of CIFE in making the decision in respect of tender evaluation or award of contract will result in rejection of the tender.
- (18) **Misleading information:** If the tenderer/tenderers deliberately gives/give any wrong information or suppresses/any material facts or makes/make false representations in this tender or creates/create circumstances for the acceptance of his/their tender, CIFE reserves the right to reject such tender at any stage or cancel the order even after acceptance of the tender at the risk and cost of the tenderer/ tenderers.
- (19) **Award of Contract:** CIFE will notify the successful tenderer in writing by Registered Letter / Speed Post / E-mail / WhatsApp to be confirm the acceptance of bid of successful bidder.
- (20) **No advance shall be given and no part payment shall be made. The Payment (through RTGS) shall be made only after the satisfactory completion of the work.**
- (21) Non-compliance with any of the conditions set forth here above is liable to result in the tender being rejected.
- (22) The quantities (like size of pandal, number of articles to be provided etc.) mentioned in the Bill of Quantities are approximate and may vary as per the actual requirement at the site. The decision of Director, CIFE shall be final and binding on all concerned in finalizing the quantities of items.
- (23) **Right of CIFE to deal with tenders :** The Director, CIFE, Mumbai, reserves the right to accept or reject any tender (whether lowest rate or not) or all the tenders at any time prior to award of contract without assigning any reasons whatsoever and no correspondence shall be entertained in this regard. CIFE also retains its right of providing work preference to public sector undertakings as admissible under Governments present policy.

SECTION – II

SPECIAL TERMS & CONDITIONS OF CONTRACT FOR ERECTION OF PANDAL

1. No advance shall be given for erection of Pandal and associated works reflected in the BoQ. **The payment shall be made as per the actual measurements (i.e. actual size of pandal erected for convocation and food arrangement) and actual number of items/articles (i.e. chair, table, sofa, fan, cooler, ACs, light, sound system, focus lamps, display boards, etc.) supplied / used during the function / programme.**
2. The waterproof Pandal (main pandal with mild steel posts, truss, and mild steel sheet roofing) should be erected in the new campus of ICAR-CIFE Mumbai for conducting the convocation. Normal / ordinary pandal shall be erected for making convocation and food arrangement in accordance with the size and specifications mentioned in the BoQ as per the instructions of the Pandal Committee.
3. The size (i.e. area) of pandal for conducting the convocation mentioned in the Bill of Quantities (BOQ) are approximate and the same may vary as per the actual requirement at the time of erection of pandal. **A joint inspection and measurement of pandal will be taken immediately after the erection of pandal/stage to avoid any ambiguity at a later stage.** Similarly, the number of items (such as chair, table, sofa, fan, light, AC, air cooler, fire extinguishers, etc.) shown in the BOQ are tentative/approximate and may vary as per the requirement. Hence; after all functions are over, the contractor has to prepare the bill in accordance with actual size of pandal and stage, and as per the actual number of items supplied / used in the function. The pandal committee of the institute will certify the bill only after the examination and verification of the measurements and bill, and after satisfactory completion of the work.
4. The Pandal shall be erected and the items like Dias, Sofas, Chairs, Table, etc. shall be placed as per the positions reflected in the enclosed drawing.
5. The Pandal of convocation should be kept ready latest by **1100 hrs. on 20th February 2026** including supply of necessary items in accordance with BoQ.
6. At least one supervisor or Representative of the Contractor must be available at the site of Pandal and stage during **rehearsal on 20th February 2026** for smooth conduct of the events (i.e. convocation) and also to look after the equipment, furniture, sound system and assisting in making other arrangements of urgent nature.
7. The Public Address System (i.e. cassette deck, mike, amplifier, speakers, recorders, 15/5 amp, switch board for connecting TV, video film, etc.) must be ready latest by **1100 hrs. on 20th February 2026** for inspection and rehearsal.

8. All arrangement must be up to the satisfaction of Pandal Committee of this Institute. Minor alteration / modifications in erection of Pandal and in the requirements of materials if needed should be done on the insistence and approval of Pandal committee only.
9. Payment shall be made only after the successful completion of the entire job up to the satisfaction of Pandal / stage Committee which will certify the work after verification of measurements and bill. **The contractor should prepare bill as per the actual size/area of the pandal and actual number of items/materials supplied for the event.** Payment shall be made through RTGS within a fortnight from the date of successful completion of job.
10. The Tender must be accompanied with an **EMD of Rs. 43,700/- (Rupees Forty Three Thousand Seven Hundred only)** in the form of Demand Draft drawn in favour of “**ICAR Unit-CIFE**” payable at Mumbai.
11. The furniture like Chair, Table, Sofa, etc. must be of uniform shape, size, color, look, and must be new ones / free from damages; Red synthetic /woolen carpet, Jalar, Khanat partition, gate cloth, etc. should be new / neatly washed.
12. Preference shall be given to the experienced Contractors / Decorators who have done similar nature of works (i.e. erection of pandal, shamiana, stage, etc.) in Government, Semi-Govt., Educational institutes and Autonomous bodies in the past.
13. ICAR-CIFE doesn't bind itself to award the contract to the lowest bidder. After opening of bids, the Pandal Committee of the institute may visit the office/store house of the bidders to inspect the condition of items. The decision of the **Director, ICAR-CIFE, Mumbai** shall be final and binding on all the concerned. No correspondence shall be entertained in such matters.
14. The rates quoted by the bidders / tenderers should be inclusive of cost of all necessary materials required for erection of Pandal, hiring charges, labour charges for complete job, transportation charges, loading and unloading charges, removal of Pandal after the programme is over, insurance etc. The **taxes as applicable** (like GST, service tax etc.) as per the norms of the Government of India should be clearly mentioned in the financial bid. The tenderers are not allowed to claim any extra amount placing the work / supply order.
15. TDS (Tax Deducted at Source) and any other tax (as applicable) will be effected as per prevailing rules. Any taxes like GST, etc., as applicable, must be mentioned clearly. Nothing extra shall be paid over and above the quoted rates in commercial / financial bid.
16. **The rate should be quoted per unit per day, and the amount quoted (for each item) shall be for required number of days. For any clarification, the Chairman of Pandal committee of ICAR-CIFE may be contacted.** The rates quoted by the tenderers shall remain firm and shall not allowed to be deviated under any circumstances till the entire convocation and other programmes are over.

17. ICAR-CIFE shall not be responsible for any type of damage caused to the furniture, PA system, Sound system, Pandal, Lights, Carpet etc. in any case (like fire accident, theft, and any unforeseen circumstances.). The contractor/bidder is responsible for taking care of the Pandal and items supplied during the programme.

18. Sound System should be of best quality. In case, the quality of sound system is found to be inferior, the Pandal Committee of CIFE has every right to reject such sound system and no payment shall be made for such inferior quality systems / items / works.

The light and sound system for cultural programme (please see the BOQ) should be of high quality; and must include disco lights, flash lights, Colour lights, special effect lights, smoke machine, etc.; and digital sound system including quality sound track, sound mixer, amplifiers, high quality cordless mikes, speaker, sound recorder, smoke machine (2 no.), and other essential sound equipment as required including DJ.

19. Illumination of the Main Academic Building, Library building, Hostels, Sports Complex, etc. shall be done with high power (200 to 250 Watt) LED flood lights / splash lamps of different colors (as instructed by the Committee) so as to cover the entire building (G+4 storied). Series lights should have different coloured LED bulbs. Trees, hedges, and buildings shall be decorated with focus lamps and series lights as per the directions of Pandal Committee.

20. The EMD shall be forfeited, if the successful bidder fails to take up the job within 2 days from the date of receipt of work order/ supply order.

21. The Earnest Money Deposit (EMD) shall be forfeited if, due to reasons whatsoever it may be, the work is not completed on scheduled time period, inferior quality and substandard items are provided / absence of supervisor or mechanic during the functions / Shamiana is not made ready within the given time and date.

22. **Security Deposit (SD):** The successful bidder will have to submit **5% of the quoted amount** for the work (i.e., **Erection of Pandal for conducting the XIX Convocation**) excluding of Taxes etc. as Security Deposit in form of Bank Guarantee or Demand Draft before the commencement of the work. The Security Deposit shall be released only after successful completion of the entire job.

23. Fresh flowers shall be used for stage decoration on Convocation Day (i.e. **21.02.2026**). Flower decoration includes border of stage backdrop, front & sides of stage, front side of the dais, and on the front edge of stage (with big flower bouquets) as directed by the Pandal Committee of the Institute.

24. The Contractor / Decorator has to carry-out all electric works in pandals and exhibition stalls & halls; works include providing main board, power plug, wiring from generator to board, connecting entire electricity load to Generator (on the day of convocation); switches, batteries, complete wiring and all electrical works, total job including everything, work also includes making wiring and electric connections for light, fan, and power points in stalls & halls in the exhibition area, each stall should be provided with 2 light points, 2 numbers of

15/5 Amp. Socket & switch (power point), and 1 fan point; including all connections to control room near by the convocation pandal, one electrician should be available on the day of convocation for operation and emergency handling/situation, etc. complete

25. The Pandal of convocation should be ready latest by **1100 hrs. on 20th February 2026** along with lighting and Public Address System etc.; failing which a penalty amounting up to 10% of the total contract value shall be deducted from the bill.
26. The decision of DIRECTOR, ICAR-CIFE shall be final for any aspect of the contract and binding to all parties concerned. **Disputes arising, if any, on the contract will be settled at his/her level by mutual consultation; and in case of failure of the settlement, dispute shall be referred to the sole arbitrator to be appointed by the Director, ICAR-CIFE, Mumbai in consultation with the Secretary, Indian Council of Agricultural Research (ICAR), New Delhi.** The decision of the sole arbitrator so appointed shall be final and binding on the parties concerned. The arbitration proceedings shall be governed by the Arbitration & Constitution Act, 1996, and amendments from time to time.
27. At the time of erection of pandal, no work (that disturbs the general public) should be carried out beyond 22:00 hours. The contractor shall be solely responsible for the consequences in case the work is executed beyond the set time line.
28. Each and every page of the tender document must be signed by the bidder failing which tender shall be rejected.
29. Any other instructions by the Pandal Committee which are necessary for smooth conduct of Convocation & other related programmes may be followed.
