# Office Order

In continuation of this Office Order of even number dated 6<sup>th</sup> January 2023 regarding the theme for **Knowledge Commercialization of the year 2023**.

The Terms of Reference (ToR) in this regards are as under:-

Technology development, technology upscaling, commercialization of products, working for the industries are some of the areas, which needs special attention from ICAR-CIFE. In this context, to promote these activities a special theme has been declared for the year 2023, as "The year of Knowledge Commercialization", with the following activities:-

1. Every division/ centre should try to develop one product which can be commercialized. This may be a **product**, **methodologies**, **consultancy or any services**.

**Academic** - Books, Mobile app, YouTube channel link to revenue generation **Students** - Mentoring students by selected faculty for promoting student entrepreneurship and generating revenue.

**Extension**- Policy document development, Advisory Service to the State / Central Govt.

- 2. Duration 01.01.2023 to 31.12.2023.
- 3. Nodal Officer to Co-ordinate different activities to be under taken as given below:
  - I. Listing the potential technologies available in the division and convening a meeting for presentation in front of all the scientists.
  - II. To Co-ordinate with HoD & OIC, Centres for commercialization of the potential technologies.
  - III. Arranging some lecture to promote commercialization of products.
  - IV. Inviting the Industry people for interaction with the scientists.
  - V. One activity to be conducted every month.
  - VI. Informing the scientists about the latest commercialized products from different institutes, especially from the fishery research institutes or CoF.

### VII. Incentives

- The APAR of the scientist (only the main inventor) will be rated as "outstanding" for a technology transfer of worth minimum Rs.1,00,000/-.
- Commercialization of technologies of worth more than Rs.10.00 lakhs will be recommended for recognition by DDG/ DG.
- Division with maximum number of technologies worth minimum Rs.5.00 Lakhs will be selected for the Best Division Awards along with suitable cash prize.
- Revenue generation from the lab of worth more than Rs.10.00 lakhs will be given one YP-II for the lab analysis for minimum one year that may be renewed on the basis of further outputs.

## 4. Short duration projects:

Six months to one-year duration projects may be given with financial support of worth Rs.50,000/- for the product development and commercialization of any previously completed work or novel idea for product development.

### 5. Student Research

- Student research having potential for product development (during the time of synopsis presentation) should be discussed within a committee to support commercialization.
- 6. It is encouraged to go for Contract Research Project/ Consultancy Project to work closely along with the industries. Centres should explore to have those projects to utilize the farm facilities available at the centre.
